All agreed to the above payments being made.

20-21/108 Repairs to playpark equipment and fencing: The chair had met with Tony Cook Group to discuss the repairs that are required to be carried out to the fencing and the old playpark equipment. A quotation had been received and all agreed for the clerk to ask Tony Cook Group to carry out the work. The chair had also asked if signs could be ordered to be attached to the fence advising that the parkland on the other side of the playpark fence is private land with no public access or right of way. The clerk has obtained a quote and will order 3 signs.

20-21/109 Grass cutting tenders 2021-2023: The clerk had received 4 tenders from grass cutting contractors wishing to tender for the 2-year contract. The clerk had emailed a spreadsheet to the councillors showing the breakdown of the costs. The councillors all agreed that the tender would be offered to the contractor who had submitted the cheapest cost and was awarded to Garden and Tree Services. The clerk had received a telephone call from Mrs. Butler, one of the church wardens from St Mary's Church advising that Garden and Tree Services carry out excellent work at the churchyard.

20-21/110 Landscaping – Dacre Lakeside Park: Concerns had been raised regarding the lack of landscaping at the above park and that it was one of the conditions of the planning approval that bunding would take place and then trees would be planted. The clerk had raised the matter with enforcement who had advised that they had spoken with the applicant's agent who had stated that the tree planting would take place once the bunding work had been completed.

20-21/111 Village issues:

Pot holes – Leven Road: The clerk is to report the problem via East Riding of Yorkshire Council 360. The pot holes are near to the layby. The clerk advised that a great amount of pot holes had recently been filled in.

Church Drive/ Main Street junction: Mr. Stones reported that the post at the said junction had been bumped into. The clerk is to report it and ask if better reflectors can be attached to the post.

Mill Lane: Mrs. Wardle reported that there was not a finger post showing the public right of way going round the golf course. The clerk is to report it.

Burton Fields development: Mr. Stones reported that the footpath has not been made leading from the new development onto New Road. The clerk is to report it.

Public Right of Way - Butts Lane to Catwick Lane via the bypass: Mr. Atkinson reported that the stile and bridge on the part of the Public Right of Way that crosses from New Road to the bypass requires work to be carried out. Also, the path from the bypass towards the jet ski centre on Catwick Lane requires way markers to show where the path goes. The clerk is to report this.

Litter – Catwick Lane: The clerk is to write to Sandsfield Gravel asking if they will carry out a litter pick from the roundabout to the quarry as there is that much rubbish collected on the verges and in the bushes and trees.
