**20-21/122** Allotment rents **2021-2022:** The clerk had circulated to the councillors a breakdown of the existing rents, the grass cutting costs and the annual water bill for the allotments prior to the meeting. If the rents were to stay the same as previous years then the rental income would be insufficient to cover the grass cutting costs and any other costs that the parish council could be liable for. All agreed to increase the rents by 10% to cover part of the grass cutting costs that the rents wouldn't meet. The clerk is to send out the annual rent letters to the allotment holders.

### 20-21/123 Village issues

**Market Cross:** Mrs. Lawson reported on the state of the base of the Market Cross and that bare brick was now showing through. All agreed that Mrs. Lawson could contact English Heritage to discuss any restoration work that could be carried out to it.

**BT Phone Box:** Mr. Olsen reported that remedial work needs to be carried out to the phone box. The clerk will contact BT.

**Corner Farm:** Concerns have been raised due to a chimney pot being removed from one of the properties on Main Street. The property is within the conservation area and the chimney pot is showing on the original planning application. The clerk is to contact planning.

Cleaning of the bus shelter: At the meeting in February discussions took place regarding the cleaning of the bus shelter. A verbal quote had been obtained and the cost would be £20 for the first clean and £15 every 4 weeks thereafter. A further quote is to be obtained. Mr. Olsen suggested that the councillors took turns in cleaning the bus shelter. To be discussed at the April meeting.

**Pot holes:** Although some of the pot holes have been filled in on Leven Road more have appeared. The clerk is to report it via Contact 360.

**New Road**: Mr.Olsen reported that the footpath along New Road needs to have work carried out to it especially in front of Dalton's Yard where the pavement floods. Tree roots are coming through the footpath in places although the parish council would not want to see the trees being cut down. Hedges are also encroaching onto the pavement from gardens.

**Roadside rubbish:** The bypass, New Road and Leven Road are in need of the litter being removed from the hedgerows. The clerk will report it to East Riding of Yorkshire Council. It was suggested that once we are out of lockdown a litter pick involving the parish council and perhaps the school could be organised. East Riding of Yorkshire Council will supply the necessary tools.
