# 20-21/135 Village issues

**Planter – Charters Lane:** The clerk had received a telephone call from a resident advising that the planter was damaged and could be a danger to children. Mrs. Whitfield had kindly dealt with the matter and advised that the planter was to be repaired. In the meantime, it had been made safe.

**Market Cross:** Mrs. Lawson is in contact with Mr. Keith Emerick from Historic England with regards to repairs to the Market Cross. Mrs. Lawson is looking to see if there are any grants available to pay for the work to be carried out. It will require specialist contractors.

**Hempholme Lane/ Mill Lane:** Mr. Atkinson asked what dates had been advised by East Riding of Yorkshire Council as to when the work was to be carried out to the road. The clerk advised that it was 29/3/221 - 9/4/21 although the road closure order is valid for 18 months.

**Catwick Lane**: It was reported that there are potholes in the road near to L V Tomlinson. The clerk is to report it via Contact 360.

**Village Taskforce Walkabout:** Mrs. Lawson has kindly agreed to meet with officers from Streetscene, East Riding of Yorkshire Council when they carry out their bi-annual walk around of the village on Tuesday, 13 April. This should have been carried out last year but due to Covid was postponed. Mrs. Lawson was supplied with a list of work that the parish council would like to be carried out which she will raise with the officers.
