Minutes of Brandesburton parish council meeting held on Monday, 9 July 2018 at 7.00pm in the Methodist Chapel schoolroom

Present: Mr. Olsen (Chair), Mrs. Mossford, Mrs. Wright, Mr. Richardson, Mrs. Whitfield, Miss. Coates, Councillor Evison, Councillor Owen.

Apologies for absence: Mr. Atkinson, Mrs. Richardson. Mrs. Hale

Residents had turned up to raise village issues therefore an open meeting was declared so that they could speak.

Mrs. Wright of Main street spoke about the problems with parking in the village. They have lived at the property for over 20 years and have not experienced the problems that they are having with cars blocking their own entrance as they are now. This was reported to ERYC 2 years ago and was assured that they would sort it out.

A lady commented that motorists cannot be bothered to walk to the shops after parking in a safe place and would rather park on the pavement causing an obstruction to pedestrians. People are having to walk out into the road to get past. Cars are still parking on both sides of the road outside of the Dacre Arms. It has also been noted that EYMS have not updated their bus timetable and it is showing that buses are still picking up on Main Street.

Councillor Evison advised that she was sorry to hear of the problems that the residents were experiencing. The real issue is the drivers and how inconsiderate they are when parking. The Traffic Regulation Order has to go through Legal before it is in place. Legal enforcement will start after 12 July 2018. A parking enforcement officer will be part of the support given by ERYC. They will issue tickets if drivers are caught parking on the double yellow lines. One resident asked if residents could issue tickets. Councillor Evison advised that they could not.

Butts Lane: A resident from Butts Lane came to complain about the litter and hedge clippings that have been left since someone has cut the hedge. The resident has picked it up herself. Councillor Evison advised that she would contact street cleansing to have it swept.

Bus stops – New Road: Councillor Evison advised that the bus stop hard standings would be in place by September 2018.

Sandsfield quarry: The village are still having problems with the smell from the site. The residents were advised to keep telephoning the Environment Agency as they are monitoring it.

The chair thanked the residents for their input and for attending the meeting.

The meeting closed at 7.30pm.

The parish council meeting opened at 7.30pm.

Minutes of previous meeting: The minutes were agreed as correct and signed by the chair.

Clerk's up-date report on on-going items:

Light – Butts Lane: The clerk had met with Peter Jacobson, ERYC to discuss the possibility of a light on Butts Lane as it is very dark on an evening and the path is now used more to walk to the bus stops on New Road. The cost to the parish council would be £1271.00 plus vat. To be included on the September agenda for discussion.

Bus shelter: The clerk has submitted a grant application to Lissett Windfarm Community fund for consideration. Applications will be considered in October 2018 and applicants will be advised if they have been successful with their application at that time.
