The clerk will contact ERYC asking for the work to be carried out.

Footpaths: Mr. Olsen had met with Mike Peeke and Rob Brown, ERYC to discuss the recent work carried out on the footpaths. 17 points were highlighted and remedial work is to be carried out to the footpaths, kerbs etc.

Christmas tree: Mr. Cammish has kindly offered to sponsor this year's Christmas tree.

Mr. Atkinson is to speak with Mr. Cammish regarding this. The clerk is to contact the school to ask if they have any events planned leading up to Christmas to see if this can coincide with the lights being switched on. If nothing is planned, then the Christmas tree and lights will be switched on Sunday, 2 December 2018. Mrs. Richardson and Mr. Richardson are to source the tree.

Village issues:

Persimmon Homes: Cllr Evison had emailed the clerk to advise that the football pitch had now been signed over to ERYC.

Struncheon Hill: Complaints had been received that vehicles over the weight limit were travelling via Bethells Bridge to get to the wedding venue at Struncheon Hill. The clerk is to write to highways, ERYC asking if they can look into this on behalf of the parish council.
