Draft minutes of Brandesburton parish council meeting held on Monday, 8 July 2019 at 7:00pm in the Methodist Church schoolroom.

Co-option of parish councillor: The clerk had contacted the 2 residents who had shown an interest in becoming a parish councillor and had invited them to the parish council meeting. As only Mr. Stones had attended the meeting, he was co-opted onto the parish council. The parish council now has 11 members.

Minutes of previous meeting: All agreed that the minutes were correct and were signed by the chair

Declaration of interest both pecuniary and non-pecuniary: None

East Riding of Yorkshire Council matters: As Councillors Owen and Evison where going to be attending another parish council the following matters were raised:

GoLGV: Residents are experiencing problems with people attending courses at GoLGV who are parking inconsiderately with no consideration for the residents trying to access or exiting their own driveways. The parish council has written to GoLGV on more than one occasion with no response. Councillor Evison suggested that the clerk contacts Tricia Danby, East Riding of Yorkshire Council to ask if the problem can be investigated.

Overgrown land – New Road: The clerk has received complaints from residents whose properties back on to the overgrown land on New Road. The matter has been reported to planning enforcement however, they are having problems tracing the owner of the land. The councillors advised the clerk who owns the land and the clerk will report back to East Riding of Yorkshire Council.

Football pitch – Mill Lane: It was reported that the car park is overgrown. Councillor Evison to take this matter up with East Riding of Yorkshire Council.

Septic tanks: This matter was raised by Mrs. Lawson. New rules will be introduced by DEFRA and the Environment Agency in January 2020. Overview and Scrutiny, East Riding of Yorkshire Council are dealing with this.

Councillors Evison and Owen left the meeting at 7:25pm.

Bus stop markings: Now that the new bus shelter is in place the clerk is to contact East Riding of Yorkshire Council to ask for 'Bus Stop' markings to be painted on the road.
